What is Zimbabwe Energy Regulatory Authority (Zera)?

The Zimbabwe Energy Regulatory Authority (ZERA) is a body corporateestablished in terms of the Energy Regulatory Authority Act [Chapter 13:23] of 2011. It is mandated to regulate the entire energy sector in Zimbabwe in a fair,transparent,efficient and cost effective manner for the benefit of the consumers and energy suppliers.

How does Zera regulate the petroleum sector in Zimbabwe?

ZERA regulates the sector through licensing audits, monitoring of prices, setting standards and specification, fuel quality audits and compliance audits. The petroleum sub-sector in Zimbabwe is deregulated and comprises of private and state owned companies.

Why is energy storage important in Zimbabwe?

In Zimbabwe,the power crisisand increasing integration of renewable energy sources like solar PV and the largely accepted bioenergy would lead to the need for energy storage. Abandoned mines and transboundary aquifers in the country can be refurbished to operate as pump energy storage plants.

Why is Harare not regulating development?

Outdated master plans, local plans and building by-lawsare failing to effectively regulate development and address the stresses caused by climate change. Enforcement of planning laws is also another issue, especially in Harare. Some settlements are just mushrooming whilst the Council ignores these developments.

Does Harare have a water supply system?
