The market for solar components is dominated by Chinese firms. India imported \$2.16 billion worth of solar photovoltaic (PV) cells, panels and modules in 2018-19.

In an effort to establish local solar manufacturing capabilities, South Africa has imposed a 10% import tariff on solar PV module and cell imported into the country. Previously, these products were exempt from import duties. The legislation was signed by the country's Finance Minister, Enoch Godongwana, on June 28 and took immediate effect.
