Once again, shippers of lithium batteries by air must prepare for changes to the regulations that become effective from 1 April. This time, the changes are buried in the multi-page packing instructions 965 and 968 of the 63 rd edition of the IATA Dangerous Goods Regulations. Neither lithium ion nor lithium metal batteries can be sent under the Section II provisions.

Lithium ion batteries are subject to further restrictions as shown below and you must declare all items which contain them when you complete the shipper"s inventory. There must be no more than two lithium ion batteries per package and these must be contained in equipment i.e. they must be inside and part of the electronic device which they power.
