

Can I post lithium batteries?

Here's what they say about posting lithium batteries. You cannot send lithium batteries on their own through domestic or international post. You can send lithium batteries in the UK or international post only when they're contained in a device (except in their Business Response, Freepost, Packetpost and Packetsort services).

Can I send a lithium battery to the UK?

The answer is yes. However, because lithium batteries are potentially so dangerous, you need to follow strict rules. A good place to start if you're in the UK is the Royal Mail. Here's what they say about posting lithium batteries. You cannot send lithium batteries on their own through domestic or international post.

Can I send lithium batteries in airmail?

No, you cannot send lithium batteries, by themselves, in the airmail. You will need to contact your local postal authority to see if you be able to ship them by surface methods i.e. sea, road and rail. If you have to send the lithium batteries by air, then you will need to send them with a freight company.

Can I send lithium-ion batteries internationally?

For example, if you are sending a mobile phone, make sure the battery is installed in the phone and you don't send a spare battery or powerbank loose in the package. Due to the risk of combustion, you cannot send lithium-ion batteries internationally.

Can I send items with lithium batteries?

Providing the postal authority has received approval from their Civil Aviation Authority, then you may be able to send items which contain lithium batteries. Power banks, which contain lithium batteries and which are used to recharge or power other devices, are categorised as lithium batteries and are not permitted under this provision.

Is lithium battery shipping dangerous?

While classified as a dangerous good, lithium battery shipping takes very specific requirements. that you can find inside the Dangerous Goods Regulations. However, if you only ship lithium batteries you can purchase the Lithium Batteries Shipping Regulations as a standalone manual.

To ensure package safety, follow shipping regulations. Use proper cushioning, mark the package as containing lithium batteries, and follow the shipping precautions set by carriers. When preparing to ship a battery backup, ensure the battery is securely installed in the equipment or, if shipped separately, is packaged to prevent short circuits.
