How do I transfer solar panels to a new property?

Letter from solicitoron company headed paper clearly stating that the solar panels were included in the purchase of the property and showing your FULL name. Alternatively a letter from the previous owner confirming this transfer showing your full name.

Can I move solar PV panels?

Yes,it is possible to move solar PV panels; however,the costs will likely outweigh the benefits. Unless you have a very large system,you will no longer be eligible for Feed-in Tariff payments. Additionally,the solar PV system's efficiency may be compromised when moved.

Can a solar PV system be moved between buildings?

This was published under the 2010 to 2015 Conservative and Liberal Democrat coalition government From summer 2019 medium and large building-mounted solar PV systems will be allowed to be moved between buildingswithout the loss of Feed-in Tariff (FIT) payments.

What is the cost to move solar PV panels?

The cost to move a solar PV installation varies greatly, with most estimates putting it between £100 and £300. So,the cost to move a 25kW installation would be between £2,500 and £7,500.

How do solar PV tariff payments work?

The tariff payments for solar PV panels are dependent on when the renewable technology is installed. The payment amount is also dependent on the Energy Performance Certificate (EPC) rating of the home where the installation is due to take place.

Can a fit accredited solar PV installation be moved?

Previously, if a FIT accredited installation was moved it became ineligible for further support. Now, landlords and tenants who cannot guarantee having long-term ownership or lease of a building can move their solar PV and keep their tariff. This change will increase flexibility and make solar PV a much more attractive investment for businesses.

Cold water is pumped up to the solar panel. Then it heats up and is transferred to a storage tank. A pump pushes cold water from the storage tank through pipes in the solar panel.
